**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY SAN ANTONIO, LOS BAÑOS, LAGUNA IN THE AMOUNT OF SEVEN HUNDRED FIFTY THOUSAND PESOS ONLY (Php 750,000.00) FOR FISCAL YEAR 2020.**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

**SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay San Antonio, Los Baños, Laguna in the amount of Seven Hundred Fifty Thousand Pesos Only (Php 750,000.00) for fiscal year 2020.

**SECTION 2. COVERAGE** – The amount of Seven Hundred Fifty Thousand Pesos (Php 750,000.00) of Barangay San Antonio, Los Baños, Laguna shall cover the expenses for MOOE under BDRRMF: Damayan sa Kapwa Kontra Covid 2019.



**SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.




