**ORDINANCE NO. 2020-2014**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY MAYONDON, LOS BAÑOS, LAGUNA IN THE AMOUNT OF SIX HUNDRED SEVENTY-FIVE THOUSAND PESOS ONLY (Php 675,000.00) FOR FISCAL YEAR 2020.**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

**SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 2 of Barangay Mayondon, Los Baños, Laguna in the amount of Six Hundred Seventy-Five Thousand Pesos Only (Php 675,000.00) for fiscal year 2020.

**SECTION 2. COVERAGE** – The amount of Six Hundred Seventy-Five Thousand Pesos Only (Php 675,000.00) of Barangay Mayondon, Los Baños, Laguna shall cover the expenses for MOOE under 20% BDF: Purchase of Relief Goods in Relation to COVID-19 Pandemic;

**SECTION 3. SOURCE OF FUNDS** – The amount of Six Hundred Seventy-Five Thousand Pesos Only (Php 675,000.00) of Barangay Mayondon, Los Baños, Laguna shall be sourced from the 20% of BDF Realignment/ Reversion / Reprogramming : 1) Acquisition of Lot for Construction of Material Recovery Facility – P500,000.00; 2) Construction of various Barangay Pathways – P 175,000.00.



**SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.




