

**ORDINANCE AMENDING SECTION 2 LETTER (C) OF ORDINANCE NO. 2020-2001 ENTITLED "ORDINANCE ADOPTING THE INTER-AGENCY TASK FORCE RESOLUTION NO. 2020-003 DATED MARCH 29, 2020, RESOLUTION PRESCRIBING THE COVID-19 GUIDELINES, POLICIES AND REGULATIONS AND PROVIDING PENALTIES FOR VIOLATION AND/OR NON-COMPLIANCE THEREWITH".**



**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

**SECTION 1. TITLE.** Ordinance Amending Section 2 Letter (C) of Ordinance No. 2020-2001 entitled "Ordinance Adopting the Inter-Agency Task Force Resolution No. 2020-003 dated March 29, 2020, *Resolution Prescribing the Covid-19 Guidelines, Policies and Regulations and Providing Penalties for Violation and/or Non-Compliance Therewith*".

**SECTION 2.** This ordinance amends Section 2 Letter C of Ordinance 2020-2001:

**SECTION 2. COVID-19 GUIDELINES.** Pursuant to the various national issuances, including but not limited to those above cited, the following guidelines hereunder shall be strictly observed:



- C. Attendance to wakes of the deceased shall be restricted and internment or cremation of the reposed shall be held within 48 hours. In case of death of PUI and to COVID-19 cases, internment or cremation shall be done within 12 hours

*Shall now read as:*

**SECTION 2. COVID-19 GUIDELINES.** Pursuant to the various national issuances, including but not limited to those above cited, the following guidelines hereunder shall be strictly observed:

- C. Attendance to wakes of the deceased shall be restricted and internment or cremation of the reposed shall be held within 24 hours. In case of death of suspected, probable and confirmed COVID-19 cases, internment or cremation shall be done within 12 hours


**SECTION 3. REPEALING CLAUSE.** All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.

**SECTION 4. EFFECTIVITY.** This Ordinance shall take effect immediately upon its approval.




