**ORDINANCE NO. 2020-2017**

**AN ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR THE UTILIZATION OF THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) IN THE MUNICIPALITY OF LOS BAÑOS AMOUNTING TO TWENTY-ONE MILLION ONE HUNDRED TWENTY THOUSAND TWO HUNDRED SIX PESOS ONLY (Php 21,120,206.00).**

**WHEREAS**, under Section 4 of Republic Act (RA) No. 11469 (the Bayanihan to Heal as One Act) granted the President the power to adopt various temporary emergency measures to respond to crisis brought about by the Coronavirus Disease 2019 (COVID-19) pandemic;

**WHEREAS**, the Department of Budget and Management has issued Local Budget Circular No. 125, dated April 07, 2020 Re: Guidelines on the release and utilization of the Bayanihan Grant to Cities and Municipalities;

**WHEREAS**, the circular is being issued to prescribe the guidelines and procedures on the release and utilization of the "Bayanihan Grant to Cities and Municipalities," hereinafter referred to as BGCM for brevity;

**WHEREAS**, Section 3.7 of the said circular states that a special account in the general fund (SAGF) for the BGCM shall be created through an ordinance;

**NOW THEREFORE**, on motion of Councilor Geronimo A. Ciceron duly seconded by Councilor Mike Dexter A. Concio and concurred by all other members present;

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA**, in session assembled, **THAT**:


**SECTION 1. BAYANIHAN GRANT TRUST ACCOUNT.** There is hereby created a special account in the general fund (SAGF) for the BGCM in the Municipality of Los Baños amounting to Twenty-One Million One Hundred Twenty Thousand Two Hundred Six Pesos Only (PhP 21,120,206.00) for easy monitoring/tracking of the utilization of such allocation.

**SECTION 2. EFFECTIVITY.** This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


