BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 3 of Barangay Maahas, Los Baños, Laguna in the amount of Eight Hundred Thousand Pesos Only (Php 800,000.00) for fiscal year 2020;
- SECTION 2. COVERAGE** – The amount of Eight Hundred Thousand Pesos (Php 800,000.00) of Barangay Maahas, Los Baños, Laguna shall cover the expenses for MOOE under 20% BDF: Purchase of Relief Goods in Relation to COVID-19 Pandemic;




SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


