**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 2 of Barangay Anos, Los Baños, Laguna in the amount of One Million Pesos Only (Php 1,000,000.00) for fiscal year 2020.
- SECTION 2. COVERAGE** – The amount of One Million Pesos (Php 1,000,000.00) of Barangay Anos, Los Baños, Laguna shall cover the expenses for MOOE under 20% BDF : Purchase of Relief Goods in Relation to COVID-19 Pandemic.




**SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


