ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY BATONG MALAKE, LOS BAÑOS, LAGUNA IN THE AMOUNT OF TWO MILLION PESOS ONLY (P 2,000,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Batong Malake, Los Baños, Laguna in the amount of Two Million Pesos Only (P 2,000,000.00) for fiscal year 2020;
- SECTION 2. COVERAGE – The amount of Two Million Pesos (P 2,000,000.00) of Barangay Batong Malake, Los Baños, Laguna shall cover the expenses for MOOE under BDRRMF: Purchase of relief good in relation to COVID 2019 Pandemic;


SECTION 3. SOURCE OF FUNDS – The amount of Two Million Pesos (P 2,000,000.00) of Barangay Batong Malake, Los Baños, Laguna shall be sourced from the Beginning Balance – 70% BDRRMF prior years of 2015-2019.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


