AN ORDINANCE CREATING THE POSITION OF EXECUTIVE ASSISTANT II (COTERMINOUS) WITH SALARY GRADE 17 AT THE OFFICE OF THE MAYOR.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. **CREATION OF POSITION.** There is hereby created a position of Executive Assistant II (Coterminous) with Salary Grade 17 at the Office of the Mayor.
- SECTION 2. **QUALIFICATIONS.** Under Section 9, Rule IV of the 2017 Omnibus Rules on Appointments and Other Human Resource Actions (Revised July 2018) which was approved through CSC Resolution No. 1800692 dated July 3, 2018, appointees to primarily confidential positions are exempt from the qualification requirements.

SECTION 3. **DUTIES AND RESPONSIBILITIES.** The duties and responsibilities shall be as follows:


- a. Assists the Municipal Mayor in all executive matters;
- b. Assists the Municipal Mayor in securing enforcement and execution of laws and regulations;
- c. Perform other function as maybe delegated by the Municipal Mayor.

SECTION 4. **SOURCE OF FUNDS.** The source of funds shall be taken from the Supplemental Budget Chargeable Against the Lump Sum Appropriation After Deducting the actual appropriation for SSL 2020. (Ordinance No. 2020-2000);

SECTION 5. **EFFECTIVITY.** This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


