**SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Timugan, Los Baños, Laguna in the amount of One Million Two Hundred Thirty Five Thousand Pesos Only (Php 1,235,000.00) for Fiscal Year 2020;**

**SECTION 2. 

**SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


**SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


