

ORDINANCE CHANGING THE NOMENCLATURE OF TWO (2) DAY CARE WORKER I TO TWO (2) CLERK III WITH SALARY GRADE 6, ITEM NUMBERS 159 AND 160, UNDER THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE (MSWDO).

WHEREAS, the Municipal Social Welfare and Development Office (MSWDO) is the heart of public service that cares, protects, develops and empowers the clientele to become functioning individuals, groups and communities. The operation of the MSWDO is grounded on the commitment of the Local Government to be more efficient and effective in the delivery of basic social services to people;

WHEREAS, the MSWDO has requested to change the nomenclature of two (2) Day Care Worker I to two (2) Clerk III with Salary Grade 6 for additional positions of its daily operation;

WHEREAS, the Human Resource and Management Office (HRMO) certifies that all pertinent provisions of Sec. 325 (f) of RA 7160 (Local Government Code of 1991) have been complied with in the reclassification / change of nomenclature of two (2) Day Care Worker I to two (2) Clerk III under Item Numbers 159 and 160;

WHEREAS, the Sangguniang Bayan is acting favorably on the request of MSWDO and the certification from HRMO;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. CHANGE OF NOMENCLATURE. There is hereby adopted changes in the nomenclature of positions under the Municipal Social Welfare and Development Office, to wit:

From : Day Care Worker I
To : Clerk III
Salary Grade : 6
Office : MSWDO
Item No. : 159, 160

SECTION 2. QUALIFICATIONS. Civil Service Commission (CSC) basic qualification standards for Clerk III Position are as follows:

EDUCATION : Completion of two years studies in college
EXPERIENCE : None Required
TRAINING : None Required
ELIGIBILITY : Career Service Subprofessional / First Level Eligibility

SECTION 3. DUTIES AND RESPONSIBILITIES. The duties and responsibilities shall be as follows:

- a. Performs clerical task such as answering telephone calls, handling mails, operating office equipment and maintaining office supplies;
- b. Gathers, complies and verifies information and performs data entry;
- c. Performs other duties that maybe assigned from time to time.

SECTION 4. SOURCE OF FUNDS. The source of funds shall be taken from the Annual Budget of CY 2020.




SECTION 7. EFFECTIVITY. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


