ORDINANCE NO. 2020-2041

ORDINANCE APPROVING THE SANGGUNIANG KABATAAN ANNUAL BUDGET OF BARANGAY TADLAC, LOS BAÑOS, LAGUNA FOR THE YEAR 2020 IN THE AMOUNT OF FOUR HUNDRED TWENTY THOUSAND EIGHT HUNDRED FIFTY PESOS ONLY (Php 420,850.00).

WHEREAS, the Sangguniang Kabataan of Barangay Tadalac, Los Baños, Laguna has prepared and submitted their 2020 Annual Budget for approval by the Sangguniang Bayan;

WHEREAS, the said Annual Budget for the year 2020 of Sangguniang Kabataan of Barangay Tadalac, was supported by a Resolution;

WHEREAS, the Annual appropriation intended for 10% SK Fund shall be provided in accordance with RA 10742 otherwise known as SK Reform Act;

WHEREAS, the Sangguniang Kabataan Annual Budget of Barangay Tadalac with the corresponding amount, as stated above, has been certified by the Punong Barangay;

WHEREAS, the SK Annual Budget, which is the financial plan embodying the estimates of the income and expenditures of the SK for one (1) fiscal year, shall be prepared in accordance with the approved Annual Barangay Youth Investment Plan (ABYIP);

WHEREAS, the budget of Sangguniang Kabataan of Barangay Tadalac has been appropriated for expenditures for General Administration Program: Maintenance and Other Operating Expenses; Capital Outlay; Sangguniang Kabataan Development and Empowerment Programs such as Health and Nutrition; Education; Economic Empowerment; Social Inclusion and Equity; Peace, Building and Security; Governance; Active Citizenship; Environment and Global Mobility; the details of which are contained in their Annual Budget Proposal;

WHEREAS, the Sangguniang Kabataan Annual Budget of Barangay Tadalac, Los Baños, Laguna was studied and reviewed by the Local Finance Committee pursuant to the provisions set forth by R.A. 7160 otherwise known as the Local Government Code;

NOW THEREFORE, on motion of Councilwoman Josephine S. Evangelista duly seconded by Councilor Miko C. Pelegrina and Councilor Janos S. Lapid and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


SECTION 1. SHORT TITLE – This ordinance shall be known as an Ordinance Approving the Sangguniang Kabataan Annual Budget of Barangay Tadalac, Los Baños, Laguna for the year 2020 in the amount of Four Hundred Twenty Thousand Eight Hundred Fifty Pesos Only (Php 420,850.00);

SECTION 2. COVERAGE - This ordinance covers the 2020 Sangguniang Kabataan Annual Budget of Barangay Tadalac;


SECTION 3. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
