BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Lalakay, Los Baños, Laguna in the amount of Eight Hundred Thousand Pesos Only (Php 800,000.00) for Fiscal Year 2020;

SECTION 2. COVERAGE – The amount of Eight Hundred Thousand Pesos (Php 800,000.00) of Barangay Lalakay, Los Baños, Laguna shall cover the expenses for Capital Outlay : Purchase of Ambulance;




SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
