AN ORDINANCE AMENDING ORDINANCE NO. 2020-2013, "AN ORDINANCE MANDATING THE USE OF FACE MASK IN PUBLIC PLACES DURING THE IMPLEMENTATION OF THE ENHANCED COMMUNITY QUARANTINE DUE TO CORONAVIRUS DISEASE 2019 (COVID-19) IN THE MUNICIPALITY OF LOS BAÑOS.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE. This ordinance is entitled as "An ordinance amending Ordinance No. 2020-2013, An ordinance mandating the use of face mask in public places during the implementation of the Enhanced Community Quarantine due to Coronavirus Disease 2019 (COVID-19) in the Municipality of Los Baños".

SECTION 2. AMENDMENTS. This ordinance amends the Title, Section 1 and Section 8 of Ordinance No. 2020-2013, to wit:

2.1. The Title of the Ordinance - AN ORDINANCE MANDATING THE USE OF FACE MASK IN PUBLIC PLACES DURING THE IMPLEMENTATION OF THE ENHANCED COMMUNITY QUARANTINE DUE TO CORONAVIRUS DISEASE 2019 (COVID-19) IN THE MUNICIPALITY OF LOS BAÑOS shall now be read as:

AN ORDINANCE MANDATING THE USE OF FACE MASKS AT ALL TIMES IN PUBLIC PLACES DURING THE DECLARATION OF A NATIONAL HEALTH EMERGENCY AND THE IMPOSITION OF ANY TYPE OF COMMUNITY QUARANTINE DUE TO CORONAVIRUS DISEASE 2019 (COVID-19) IN THE MUNICIPALITY OF LOS BAÑOS.

2.2. Accordingly, SECTION 1 - TITLE. This ordinance is entitled as "An ordinance mandating the use of face mask in public places during the implementation of the Enhanced Community Quarantine due to Coronavirus Disease 2019 (COVID-19) in the Municipality of Los Baños shall now be read as:


SECTION 1. TITLE. This ordinance is entitled as "An Ordinance mandating the use of face masks at all times in public places during the declaration of a National Health Emergency and the imposition of any type of community quarantine due to Coronavirus Disease 2019 (COVID-19) in the Municipality of Los Baños".

2.3. SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval and shall be in full force and effect only during the implementation of Enhanced Community Quarantine shall now be read as:

SECTION 8. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval and shall be in full force and effect only during the implementation of any type of Community Quarantine in the municipality.

SECTION 3. REPEALING CLAUSE. All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.




SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
