ORDINANCE NO. 2020-2045

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY BAYOG, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE MILLION THREE HUNDRED THOUSAND PESOS ONLY (PHP 1,300,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Bayog, Los Baños, Laguna in the amount of One Million Three Hundred Thousand Pesos Only (Php 1,300,000.00) for Fiscal Year 2020;

SECTION 2. COVERAGE – The amount of One Million Three Hundred Thousand Pesos (Php 1,300,000.00) of Barangay Bayog, Los Baños, Laguna shall cover the expenses for Personal Services : COVID-19 Hazard Pay for Barangay Personnel – Php 200,000.00; MOOE: Gasoline Expenses – Php 120,000.00; Electricity Expenses – Php 90,000.00; Water Expenses – Php 30,000.00; Office Supplies – Php 30,000.00; Repair and Maintenance (Motor Vehicle) – Php 30,000.00; 20% BDF : Procurement of Ambulance – Php 800,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Five Hundred Thousand Pesos (Php 500,000.00) shall be sourced from the Beginning Balance (General Fund) ; and the amount of Eight Hundred Thousand Pesos (Php 800,000.00) shall be sourced from Continuing Balance 20% BDF Year 2019 of Barangay Bayog, Los Baños, Laguna;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
