ORDINANCE NO. 2020-2047

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY BAYBAYIN, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED FIFTY-FOUR THOUSAND PESOS ONLY (PHP 1,754,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Baybayin, Los Baños, Laguna in the amount of One Million Seven Hundred Fifty-Four Thousand Pesos Only (Php 1,754,000.00) for Fiscal Year 2020;

SECTION 2. COVERAGE – The amount of One Million Seven Hundred Fifty-Four Thousand Pesos (Php 1,754,000.00) of Barangay Baybayin, Los Baños, Laguna shall cover the expenses for MOOE : Training Expenses – Php 50,000.00; Office Supplies Expenses – Php 50,000.00; Fuel, Oil and Lubricant Expenses – Php 35,000.00; Other Supplies and Materials

Expenses – Php 70,000.00; Electricity Expenses – Php 35,000.00; Representation Expenses – Php 46,000.00; CAPITAL OUTLAY under 20% Barangay Development Fund: Furniture and Fixtures – Php 50,000.00; Construction and Rehabilitation of Multi-Purpose Hall – Php 1,418,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Three Hundred Thirty Six Thousand Pesos (Php 336,000.00) shall be sourced from Beginning Balance (General Fund) and One Million Four Hundred Eighteen Thousand Pesos (Php 1,418,000.00) of Barangay Baybayin, Los Baños, Laguna shall be sourced from the Continuing Balance 20% Barangay Development Fund;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
