ORDINANCE NO. 2020-2048

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY MALINTA, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED THOUSAND PESOS ONLY (PHP 1,800,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Malinta, Los Baños, Laguna in the amount of One Million Eight Hundred Thousand Pesos Only (Php 1,800,000.00) for Fiscal Year 2020;

SECTION 2. COVERAGE – The amount of One Million Eight Hundred Thousand Pesos (Php 1,800,000.00) of Barangay Malinta, Los Baños, Laguna shall cover the expenses for MOOE : Other Supplies and Materials Expenses – Php 100,000.00; Fuel, Oil, Lubricants Expenses – Php 170,000.00; Electricity Expenses –Php 150,000.00; Repair and Maintenance – Motor Vehicle Exp. – Php 80,000.00 ; 20% BARANGAY DEVELOPMENT FUND: Purchase of relief goods in relation to COVID-19 Pandemic –

Php 1,200,000.00; Procurement of One (1) unit Ambulance (additional) –
Php – 100,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Five Hundred Thousand Pesos (Php 500,000.00) shall be sourced from Beginning Balance (General Fund) and One Million Three Hundred Thousand Pesos (Php 1,300,000.00) of Barangay Malinta, Los Baños, Laguna shall be sourced from the Continuing Balance 20% BDF 2015-2019;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
