ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY TIMUGAN, LOS BAÑOS, LAGUNA IN THE AMOUNT OF SEVEN HUNDRED THOUSAND PESOS ONLY (PHP 700,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Timugan, Los Baños, Laguna in the amount of Seven Hundred Thousand Pesos Only (Php 700,000.00) for Fiscal Year 2020;

SECTION 2. COVERAGE – The amount of Seven Hundred Thousand Pesos (Php 700,000.00) of Barangay Timugan, Los Baños, Laguna shall cover the expenses for MOOE : Fuel, Oil, Lubricants Expenses – Php 100,000.00; Electricity Expenses –Php 100,000.00; Repair and Maintenance – Motor Vehicle Exp. – Php 50,000.00 ; Other Supplies Expenses – Php 15,000.00; Telephone Expenses-Php 11,000.00; Water Expenses –

Php 24,000.00; CAPITAL OUTLAY: Procurement of 2 unit Air-Condition with installation – Php-140,000.00; Procurement of 2 sets 120cm Office Table L-Type with Center Drawer, Mobile Pedestal inclusive of clerical chair, 1 sets Executive Table and Chair, 10 Table (Session), 11 Chair (Session), 1 pc Lateral 4 Layers Steel Cabinet, 1 pc Vertical Swing 2 Doors Steel Cabinet – Php 260,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Seven Hundred Thousand Pesos (Php 700,000.00) shall be sourced from Beginning Balance (General Fund) of Barangay Timugan, Los Baños, Laguna;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
