ORDINANCE NO. 2020-2051

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY BAMBANG, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED THOUSAND PESOS ONLY (PHP 1,700,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Bambang, Los Baños, Laguna in the amount of One Million Seven Hundred Thousand Pesos Only (Php 1,700,000.00) for Fiscal Year 2020;

SECTION 2. COVERAGE – The amount of One Million Seven Hundred Thousand Pesos Only (Php 1,700,000.00) of Barangay Bambang, Los Baños, Laguna shall cover the expenses for **MOOE**: Procurement of LPG,

Bulbs and other electrical supplies, kitchen supplies, kitchen box, and water dispenser – Php 200,000.00; Payment of Gasoline – Php 200,000.00; Payment of Electrical Consumption – Php 100,000.00; Payment for Water Consumption – Php 20,000.00; Payment of Office Supplies P60,000.00; Payment of Internet Consumption – Php 25,000.00; Procurement for Drugs and Medicines – Php 30,000.00; Procurement of Medical Equipment, Oxygen Tank and Filter – Php 15,000.00; Procurement of Tables and Chairs, Electric Fan, Small Cabinet with drawer – Php 50,000.00; and under **20% Barangay Development Fund**: *Social Development* : Rehabilitation of Multi-Purpose Hall at 2nd Floor – Php 138,163.21; Rehabilitation of Boundary Market at Purok 1 – Php 42,512.60; *Economic Development* : Construction of pathway with Canopy at Bambang Elementary School –Php 574,553.10; Construction of Barangay Pathways at Purok 4 – Php 15,975.64; *Environmental Development*: Construction of MRF at Purok 5, Upper Dampalit – Php 228,795.45;


SECTION 3. SOURCE OF FUNDS – The amount of Seven Hundred Thousand Pesos (Php 700,000.00) shall be sourced from the Beginning Balance (General Fund) and One Million Pesos (Php 1,000,000.00) shall be sourced from the Continuing Balance 20% BDF Prior Years 2017-2018 of Barangay Bambang, Los Baños, Laguna



SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


