ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY LALAKAY, LOS BAÑOS, LAGUNA IN THE AMOUNT OF FOUR HUNDRED THOUSAND PESOS ONLY (PHP 400,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, **THAT:**

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 4 of Barangay Lalakay, Los Baños, Laguna in the amount of Four Hundred Thousand Pesos Only (Php 400,000.00) for Fiscal Year 2020;
- SECTION 2. COVERAGE** – The amount of Four Hundred Thousand Pesos Only (Php 400,000.00) of Barangay Lalakay, Los Baños, Laguna shall cover the expenses for MOOE FUND: Payment of Electricity Consumption – Php 65,000.00; Payment of Fuel Consumption – Php 80,000.00; Procurement Kitchen Utensils – Php 5,000.00; CAPITAL OUTLAY : Procurement of 3 unit of 4 layer steel cabinet – Php 50,000.00; 20% DEVELOPMENT FUND: Rehabilitation of Multi-Purpose Hall – Php 200,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Four Hundred Thousand Pesos Only (Php 400,000.00) of Barangay Lalakay, Los Baños, Laguna shall be sourced from the Beginning Balance (General Fund) – Php 200,000.00; Continuing Balance (20% BDF prior year 2019);

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
