ORDINANCE APPROVING THE SANGGUNIANG KABATAAN SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY LALAKAY, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE HUNDRED SEVENTY SIX THOUSAND THREE HUNDRED THIRTY SIX PESOS AND 60/100 ONLY (Php 176,336.60) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Sangguniang Kabataan Supplemental Budget No. 1 of Barangay Lalakay, Los Baños, Laguna in the amount of One Hundred Seventy Six Thousand Three Hundred Thirty Six Pesos and 60/100 Only (Php 176,336.60) for Fiscal Year 2020;
- SECTION 2. COVERAGE** – The amount of One Hundred Seventy Six Thousand Three Hundred Thirty Six Pesos and 60/100 Only (Php 176,336.60) of Sangguniang Kabataan of Barangay Lalakay, Los Baños, Laguna shall cover the expenses for General Administrative Program- MOOE: Procurement of Office Supplies – Php 23,000.00; Repainting of SK Office and Repair of Office Door / Electric Wiring – Php 40,000.00; Payment of Fidelity Bond Premium – Php 2,000.00; Payment of

Accountable Forms – Php 2,000.00; Procurement of One (1) Unit Stand Fan – Php 2,000.00; CAPITAL OUTLAY : Procurement of One (1) unit Four (4) layer Filling Cabinet – Php 20,000.00; Procurement of One (1) unit Laptop with Printer – Php 50,000.00; HEALTH : Procurement of Face Shield and Face Mask – Php 37,336.60;


SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Seventy Six Thousand Three Hundred Thirty Six Pesos and 60/100 Only (Php 176,336.60) of Sangguniang Kabataan of Barangay Lalakay, Los Baños, Laguna shall be sourced from the Sangguniang Kabataan Continuing Balance Prior Year 2017-2019;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
