ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY ANOS, LOS BAÑOS, LAGUNA IN THE AMOUNT OF THREE HUNDRED FORTY THOUSAND PESOS ONLY (PHP 340,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 4 of Barangay Anos, Los Baños, Laguna in the amount of Three Hundred Forty Thousand Pesos Only (P340,000.00) for Fiscal Year 2020;
- SECTION 2. COVERAGE** – The amount of Three Hundred Forty Thousand Pesos (P340,000.00) of Barangay Anos, Los Baños, Laguna shall cover the expenses for MOOE: Payment of Accountable Forms –P 5,000.00; Payment of Office Supplies – P 20,000.00; Payment of Gasoline Expenses – P 50,000.00; Payment of Electricity Expenses – P50,000.00; Payment for Water Expenses – P 20,000.00; Procurement of Disinfectant

& Alcohol – P40,000.00; Procurement of Power Sprayer & Rechargeable drill – P20,000.00; Payment for Tel/Mobile Expenses – P 20,000.00; Payment for Internet Expenses – P 5,000.00; Payment for Repair / Maintenance of Brgy. Vehicle –P 50,000.00; CAPITAL OUTLAY: Procurement of 6 Units Cellphone – P 60,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Three Hundred Forty Thousand Pesos (P340,000.00) of Barangay Timugan, Los Baños, Laguna shall be sourced from the Beginning Balance 2020;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


