ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY MAYONDON, LOS BAÑOS, LAGUNA IN THE AMOUNT OF THREE HUNDRED TWENTY THOUSAND PESOS ONLY (PHP 320,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 3 of Barangay Mayondon, Los Baños, Laguna in the amount of Three Hundred Twenty Thousand Pesos Only (P320,000.00) for Fiscal Year 2020;
- SECTION 2. COVERAGE** – The amount of Three Hundred Twenty Thousand Pesos (P320,000.00) of Barangay Mayondon, Los Baños, Laguna shall cover the expenses for MOOE: Purchase of Office Supplies –P 50,000.00; Payment of Gasoline Consumption – P 50,000.00; Payment of Electricity Consumption – P50,000.00; Repair and Maintenance of Transportation

Equipment – P 50,000.00; 20% BDF: Purchase of Relief Goods in relation to COVID-19 Pandemic – P 120,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Three Hundred Twenty Thousand Pesos (P320,000.00) of Barangay Mayondon, Los Baños, Laguna shall be sourced from the Realignment / Reversion / Reprogramming of CAPITAL OUTLAY: Communication Equipment – P110,000.00; Furniture and Fixtures – P 90,000.00; 20% BDF : Construction/ Rehabilitation of Drainage Canals – P 120,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


