ORDINANCE NO. 2020-2065

ORDINANCE APPROVING AND ADOPTING THE MUNICIPAL TRICYCLE PEDICAB FRANCHISING AND REGULATORY BOARD (MTPFRB) RESOLUTION NO. 2020-10, DATED OCTOBER 7, 2020 ENTITLED "RESOLUTION RECOMMENDING TO THE SANGGUNIANG BAYAN TO ALLOW OWNERS/OPERATORS WHO ARE ABROAD, CONFINED IN HOSPITAL OR ARE PHYSICALLY INCAPACITATED TO RENEW THEIR FRANCHISE THROUGH HIS/HER DULY AUTHORIZED REPRESENTATIVE."

WHEREAS, the Sangguniang Bayan of Los Baños enacted Municipal Ordinance 2011-1082 dated October 17, 2011 entitled "New Municipal Ordinance on the Franchise and Operation of Motorized Tricycles in Los Baños, Laguna to be known as the "New Ordinance for Tricycles in the Municipality of Los Baños"/ *Bagong Kautusang Pambayan na Nagsasaad ng Pagpapaprangkisa at Pamamahala ng Operasyon sa Lahat ng Traysikel na may Motor sa Bayan ng Los Baños, Laguna na Tatawaging "Bagong Ordinansa para sa mga Traysikel sa Bayan ng Los Baños"*;

WHEREAS, Ordinance No. 2011-1082 and Executive Order No. 149 Series of 2019 both state the powers and functions of the Municipal Tricycle Pedicab Franchising and Regulatory Board (MTPFRB) as a policy making body and define the Tricycle Regulatory Unit (TRU) as the implementing body of the Board under the management and supervision of the Office of the Municipal Mayor thru the Office of the Municipal Treasurer;

WHEREAS, Ordinance No. 2014-1305 amended the said Ordinance which states that Subsection 24.5 of Section 24, Article VIII, Cancellation of Franchise, "Non-renewal of franchise after one (1) month of its yearly expiration date" shall now be read as "*Non-renewal of franchise after three (3) months of its yearly expiration shall be cancelled, thus, the operator/owner shall re-apply as a New Franchise and submit all the needed requirements, subject to an available slot.*";

WHEREAS, during the MTPFRB Meeting on October 7, 2020, the TRU has reported that there were a number of requests from owners/operators of tricycle-for-hire units to allow their duly authorized representatives to apply for the renewal of franchise on their behalf. TRU cited a case of an owner who is abroad and he/she cannot fly back home due to travel constraints in view of the COVID-19 pandemic. Other cases are that of an owner/operator who is confined in a hospital or he/she is physically incapacitated;


WHEREAS, only for those aforementioned cases that the Board consented to recommend to the Sangguniang Bayan to allow owners/operators to renew their franchise through his/her duly authorized representative, provided proper documents for the purpose shall be secured by the duly authorized representative;

NOW THEREFORE, on motion of Councilor Marlo PJ A. Alipon duly seconded by Councilor Cris Dayril B. Bagnes and concurred by all other members present;


RESOLVED AS IT IS HEREBY RESOLVED, an Ordinance approving and adopting the Municipal Tricycle Pedicab Franchising And Regulatory Board (MTPFRB) Resolution No. 2020-10, dated October 7, 2020 entitled "Resolution recommending to the Sangguniang Bayan to allow owners/operators who are abroad, confined in hospital or are physically incapacitated to renew their franchise through his/her duly authorized representative."
