ORDINANCE NO. 2020-2066

ORDINANCE APPROVING AND ADOPTING THE MUNICIPAL TRICYCLE PEDICAB FRANCHISING AND REGULATORY BOARD (MTPFRB) RESOLUTION NO. 2020-12, DATED OCTOBER 7, 2020 ENTITLED "RESOLUTION RECOMMENDING TO THE SANGGUNIANG BAYAN FOR THE REIMPOSITION OF SURCHARGE / PENALTY FOR AN OPERATOR WITH AN EXPIRED FRANCHISE WHO APPLIES FOR RENEWAL AS PROVIDED IN SECTION 12, ARTICLE V OF ORDINANCE NO. 2011-1082."

WHEREAS, the Sangguniang Bayan of Los Baños enacted Municipal Ordinance 2011-1082 dated October 17, 2011 entitled "New Municipal Ordinance on the Franchise and Operation of Motorized Tricycles in Los Baños, Laguna to be known as the "New Ordinance for Tricycles in the Municipality of Los Baños"/ *Bagong Kautusang Pambayan na Nagsasaad ng Pagpaparangkisa at Pamamahala ng Operasyon sa Lahat ng Traysikel na may Motor sa Bayan ng Los Baños, Laguna na Tatawaging "Bagong Ordinansa para sa mga Traysikel sa Bayan ng Los Baños";*

WHEREAS, Ordinance No. 2011-1082 and Executive Order No. 149 Series of 2019 both state the powers and functions of the Municipal Tricycle Pedicab Franchising and Regulatory Board (MTPFRB) as a policy making body and define the Tricycle Regulatory Unit (TRU) as the implementing body of the Board under the management and supervision of the Office of the Municipal Mayor thru the Office of the Municipal Treasurer;

WHEREAS, Ordinance No. 2014-1305 dated February 10, 2020 amended the said Ordinance which states that Section 12 of Article V shall now be read as "No surcharge shall be collected from an operator with an expired franchise, hence, they have to re-apply as a New Franchise and submit all needed requirements, subject to an available slot". Furthermore, Ordinance No. 2014-1305 also amended Subsection 24.5 of Section 24, Article VIII Cancellation of Franchise which now states that, "*Non-renewal of franchise after three (3) months of its yearly expiration shall be cancelled, thus, the operator/owner shall re-apply as a New Franchise and submit all the needed requirements, subject to an available slot.*";

WHEREAS, the Board observed that most of the owners/operators were applying for the renewal of their franchise on the third month from its yearly expiration. To discourage owners/operators with this practice and to further regulate them, the Board has recommended for the reimposition of surcharge/penalty;

WHEREAS, after careful review and deliberation, the Sangguniang Bayan agreed to approve and adopt the reimposition of surcharge / penalty for an operator with an expired franchise who applies for renewal as provided in Section 12, Article V of Ordinance No. 2011-1082;

NOW THEREFORE, upon motion of Councilor Marlo PJ A. Alipon duly seconded by Councilwoman Josephine S. Evangelista and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, **THAT**:

SECTION 1. ARTICLE V. Fees and Charges.

SECTION 12. (Ordinance No. 2014-1305) "No surcharge shall be collected from an operator with an expired franchise, hence they have to re-apply as a New Franchise and submit all the needed requirements, subject to an available slot.

Shall now read as:

"A surcharge of twenty-five (25%) of the total fees for every month after its yearly expiration shall be collected from an operator with an expired franchise who applies for renewal";

SECTION 2. SEPARABILITY CLAUSE. This ordinance partly amends repeals and modify Ordinance No. 2014-1305. Any inconsistency with previous / other ordinances, this ordinance shall prevail. Any part which has been declared unconstitutional, the other part shall remain in force.

SECTION 3. REPEALABILITY CLAUSE. All ordinances, rules and regulations inconsistent with this ordinance are hereby repealed and modified accordingly.




SECTION 4. EFFECTIVITY. This ordinance shall take force and effect upon approval.



