**ORDINANCE NO. 2020-2076**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY BAYOG, LOS BAÑOS, LAGUNA IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS ONLY (PHP 300,000.00) FOR FISCAL YEAR 2020.**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA**, in session assembled, **THAT:**

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 4 of Barangay Bayog, Los Baños, Laguna in the amount of Three Hundred Thousand Pesos Only (Php 300,000.00) for Fiscal Year 2020;
- SECTION 2. COVERAGE** – The amount of Three Hundred Thousand Pesos of Barangay Bayog, Los Baños, Laguna shall cover the expenses for MOOE: Gasoline Expenses – Php 90,000.00; Electricity Expenses – Php 80,000.00; Office Supplies – Php 40,000.00; Other Supplies and Materials Expenses (Alcohol, Disinfectant, Sanitizer, Face Mask, etc.) – Php 50,000.00; CAPITAL OUTLAY : One (1) Unit of Inverter Aircon Split Type – Php 40,000.00;



- SECTION 3. SOURCE OF FUNDS** – The amount of Three Hundred Thousand Pesos of Barangay Bayog, Los Baños, Laguna shall be sourced from the Beginning Balance (General Fund) ;
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;
- SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


