ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY BAMBANG, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS ONLY (PHP 100,000.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 4 of Barangay Bambang, Los Baños, Laguna in the amount of One Hundred Thousand Pesos Only (Php 100,000.00) for Fiscal Year 2020;

SECTION 2. COVERAGE – The amount of One Hundred Thousand Pesos of Barangay Bambang, Los Baños, Laguna shall cover the expenses for MOOE: Stockfilling of food and Non food item – Php 40,000.00; Procurement of rubber boots, gloves, raincoat, heavy duty flashlight, Radio, first aid kit – Php 60,000.00




- SECTION 3. SOURCE OF FUNDS** – The amount of One Hundred Thousand Pesos of Barangay Bambang, Los Baños, Laguna shall be sourced from the Beginning Balance (General Fund) ;
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION** – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;
- SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


