BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, **THAT:**

- SECTION 1. TITLE** – Ordinance approving the Sangguniang Kabataan Supplemental Budget No. 1 of Barangay Mayondon, Los Baños, Laguna in the amount of Two Hundred Seventy Four Thousand Twenty Three Pesos Only (Php 274,023.00) for Fiscal Year 2020;


SECTION


