ORDINANCE NO. 2020 – 2089

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET AMOUNTING TO FIVE HUNDRED THOUSAND PESOS (PHP 500,000.00) AS REWARD MONEY FOR THE EARLY APPREHENSION/CAPTURE OF THE PERPETRATORS IN THE KILLING OF HONORABLE MAYOR CAESAR P. PEREZ CHARGEABLE AGAINST THE GENERAL FUND – SAVINGS (BEGINNING BALANCE CY 2020) AND FURTHER CREATING A TRUST FUND FOR THE PURPOSE.

WHEREAS, Honorable Mayor Caesar Pabalate Perez was treacherously killed by still unknown assailants in the municipal compound on Thursday evening, 03 December 2020;

WHEREAS, the senselessness and brutality of the killing of Mayor Perez has caused widespread pain and indignation from various sectors Los Baños community and is mourning for his untimely demise and demanding for justice;

WHEREAS, Mayor Perez, 66 years old, had been in the public service for thirty-one (31) years. He had served as the Barangay Chairman of Batong Malake from 1989 to 2001; Municipal and Provincial Liga ng mga Barangay President from 1989 to 2001, Vice Governor of Laguna from 2010 to 2013; and, as Municipal Mayor of Los Baños from 2001 to 2010 and 2014 to 2020;

WHEREAS, the Sangguniang Bayan of Los Baños condemns the killing of Honorable Mayor Perez. His killing is a wanton disregard for human rights and human life and must immediately be investigated. The august body call on all government authorities for a speedy investigation and resolution of the case and to bring forth the culprits into the hands of justice through Resolution No. 2020-204;

WHEREAS, the Sangguniang Bayan believes that putting a bounty would encourage people from coming out with the right information that will lead to the apprehension of the perpetrators in the killing of Mayor Perez;

NOW THEREFORE, on motion of Councilor Geronimo A. Ciceron, duly seconded by Councilor Marlo PJ A. Alipon and approved by the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA in session assembled **THAT**:

SECTION 1. There is hereby appropriated from the municipal funds an amount of **Five Hundred Thousand Pesos Only (P 500,000.00)** for the reward money for early apprehension of the perpetrators in the killing of Honorable Mayor Caesar P. Perez.


SECTION 2. The **Creation of Trust Fund** for the appropriated budget for the reward money for the early apprehension of the perpetrators in the killing of Honorable Mayor Caesar P. Perez is hereby authorized.

SECTION 3. The Source of Funds shall be taken from the **General Fund – Savings (Beginning Balance CY 2020)**.

SECTION 4. This Ordinance shall take force and effect upon approval by the Sangguniang Bayan subject to all existing auditing rules and regulations.


