SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 5 of Barangay Anos, Los Baños, Laguna in the amount of Five Hundred Thousand Pesos Only (Php 500,000.00) for Fiscal Year 2020;

SECTION 2. COVERAGE – The amount of Five Hundred Thousand Pesos (Php 500,000.00) of Barangay Anos, Los Baños, Laguna shall cover the expenses for 20% BDF - Provision of Food and Non-Food item for marginalized Sector affected by COVID-19 Pandemic;



SOURCE OF FUNDS – The amount of Five Hundred Thousand Pesos (Php 500,000.00) of Barangay Anos, Los Baños, Laguna shall be sourced from **20% BDF Realignment / Reversion / Reprogramming**: Purchase of Parcel Lot for Housing Project- Php 200,000.00; Installation / Rehabilitation of Streetlights – Php 80,000.00; Purchase of Barangay Rescue Vehicles – Php 80,000.00; Rehabilitation of Covered Courts – Php – 70,000.00; Fabrication of Portable bleachers – Php 70,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


