AN ORDINANCE PROHIBITING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION OR USE OF FIRECRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES AND THE EXPLODING OF FIRECRACKERS OR OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF LOS BAÑOS.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA in its session assembled, **THAT:**

SECTION 1. PURPOSE OF THIS ORDINANCE – It is the purpose of this Ordinance to prohibit the manufacture, sale, distribution and use of firecrackers or pyrotechnic devices and such other similar devices and the exploding of firecrackers and other explosives within the Municipality of Los Baños in furtherance of public safety, peace, order and security of the community;

SECTION 2. PROHIBITED ACTS.

(a) It shall be unlawful for any person or business establishment to manufacture, sell or offer for sale, possess or use any firecracker or pyrotechnic device or such other similar devices within the territory of the Municipality of Los Baños.

(b) It shall, likewise, be unlawful for any person to discharge or explode, or cause to discharge or to explode, any firecracker, or any other explosive or to use any pyrotechnic device or any such other similar device, at anytime and anywhere within the territory of the Municipality of Los Baños.

SECTION 3. PENALTIES. – Violation of any of the provisions of Section 2 of this Ordinance shall be penalized as follows:

FIRST OFFENSE: A fine of One Thousand Pesos (P1,000.00).

SECOND OFFENSE: A fine of One Thousand Five Hundred Pesos (P1,500.00).

THIRD OFFENSE: A fine of Two Thousand Five Hundred Pesos (P2,500.00) or imprisonment of not more than six (6) months or both in the discretion of the Court.

If the violation is committed by a business establishment, the President of General Manager or the person, acting in behalf of either the President or the General Manager shall be held liable in the case of corporation or partnership, or the owner or proprietor or the person acting in his behalf shall be held responsible in the case of single proprietorship.

In addition to the foregoing penalties, the business permit of the business establishment shall be cancelled by the Municipal Mayor upon the commission of the third offense.

SECTION 4. IMPLEMENTING BODY. – The persons who are authorized to implement the aforementioned provision are the following:

- A. The Local Chief Executive;
- B. The Philippine National Police;
- C. Barangay Officials; and
- D. Other law enforcement agents, non-government organizations/entities or persons as may be duly deputized by the Local Chief Executive.

SECTION 5. REPEALING CLAUSE. – All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 6. SEPARABILITY CLAUSE. – If, for any reasons, any part or provision of this Ordinance shall be declared unconstitutional or invalid by the court, or suspended or revoked by competent authorities, other parts or the provisions thereof which are not affected thereby shall continue to be full force and effect.


SECTION 7. EFFECTIVITY. – This Ordinance shall take effect immediately upon its approval.


