ORDINANCE NO. 2021-2119

AN ORDINANCE MANDATING THE INCREASE IN THE COMPENSATION OF JOB ORDER EMPLOYEES OF THE MUNICIPAL GOVERNMENT OF LOS BAÑOS AND APPROPRIATING FUNDS THEREOF.

WHEREAS, subject to Section 16 of R.A. 7160 otherwise known as the Local Government Code of 1991, Local Government Units shall exercise power expressly granted, those which are essential to the promotion of general welfare; enhance economic prosperity and social justice; promote full employment ; and preserve the convenience and comfort of the inhabitants;

WHEREAS, Section 81 of the same code, states that: “ The compensation of local officials and personnel shall be determined by the Sanggunian concerned and that increase in compensation of employees shall take effect as provided in the Ordinance”;

WHEREAS, the compensation of Job Order employees was ordained and has never been increased since CY 2015;

WHEREAS, due to the yearly increase in the rate of inflation in the country, the continuing increase in the prices of basic commodities and services and the effect of the COVID-19 pandemic to the financial capacity of every Filipino family, the compensation of daily wage earners must be reasonably adjusted;

WHEREAS, in consultation with the Local Finance Committee, funds can be made available to adjust the compensation of Job Order Employees of the Municipal Government of Los Baños at a sustainable rate;

NOW THEREFORE, on motion of Councilor Janos S. Lapiz duly seconded by Councilor Geronimo A. Ciceron and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. The compensation of Job-Order Employees shall be increased / adjusted according to the following rate:


CATEGORY	FROM	TO
a. Non-skilled Job Order (Office and General Labor)	P 368.00	P 410.00
b. Skilled Job Order (Heavy Equipment & 10 Wheeler Truck Operator)	P 400.00	P 450.00
c. Special Designation Job Order	P 450.00	P 500.00

SECTION 2. The increase in compensation shall take effect upon approval of authorities, retro-active to March 1, 2021.


SECTION 3. Funds shall be appropriated from the General Fund, without prejudice to those Job Order Employees designated at the Economic Enterprise units of Municipal Government of Los Baños.


