WHEREAS, Barangay Bambang, Los Baños, Laguna has prepared and submitted their 2021 Annual Budget for approval of the Sangguniang Bayan;

WHEREAS, the said Annual Budget for the year 2021 of Barangay Bambang was supported by a Resolution and an Ordinance;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:



SECTION 2. COVERAGE - This Ordinance covers the 2021 Annual Budget of Barangay Bambang.


SECTION 3. EFFECTIVITY – This Ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
