**WHEREAS**, Barangay Malinta, Los Baños, Laguna has prepared and submitted their 2021 Annual Budget for approval of the Sangguniang Bayan;

**SECTION 1.** TITLE – This Ordinance shall be known as an Ordinance approving the 2021 Annual Budget of Barangay Malinta, Los Baños, Laguna in the amount of Seven Million Five Hundred Seventy Eight Thousand Seven Hundred Seventy Seven Pesos (P 7,578,777.00).


**SECTION 2.** COVERAGE - This Ordinance covers the 2021 Annual Budget of Barangay Malinta.

**SECTION 3.** EFFECTIVITY – This Ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


