BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:



SECTION 2. COVERAGE - This Ordinance covers the 2021 Annual Budget of Barangay Tuntungin-Putho.


SECTION 3. EFFECTIVITY – This Ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


