

ORDINANCE NO. 2021- 2128

AN ORDINANCE AMENDING ARTICLE 2 SECTION 4.13 OF ORDINANCE NO. 2011-1082 PERTAINING TO THE DEFINITION OF TRICYCLE

WHEREAS, The Local Government Code of 1991 mandates the Sangguniang Bayan to regulate the operation of tricycles, enact ordinances granting franchises, and authorize the issuance of permits or licenses for the operation thereof within territorial jurisdiction of the municipality or the city;

WHEREAS, Pursuant to legislative authority granted by the Local Government Code of 1991, the Sangguniang Bayan shall, subject to the guidelines prescribed by the Department of Transportation (DOT), regulate the operation of tricycles for their operation thereof within the territorial jurisdiction of Los Baños, province of Laguna;

WHEREAS, the Municipality of Los Baños shall continue to explore alternative energy and technology options, which include electric vehicles like E-Tricycles and other non-conventional three-wheeled vehicle, that can reduce green gas emissions from the municipality should be issued permits or licenses and granted franchises by the Sangguniang Bayan;

WHEREAS, the Sangguniang Bayan and the Local Government Unit shall recognize, promote, and protect the rights of every worker using public utility tricycles through inclusivity regardless of model classification;

NOW THEREFORE, on motion of Councilor MARlo PJ A. Alipon duly seconded by Councilor Janos S. Lapiz and concurred by all Councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. This ordinance amends Article 2 Section 4.13 of Ordinance No. 2011-1082:

“Tricycle – means a motor vehicle composed of a motorcycle fitted to a single-wheeled side car to render transport services or to convey passengers/goods for public and private use.”

Shall now read as:

“Public Utility Tricycle – shall refer to a motorcycle/side car unit granted with franchise by the Municipal Government of Los Baños to operate and transport passengers within the municipality, it shall likewise include a three-wheeler passenger vehicle, with model classification of non-conventional three-wheeled motorized vehicle granted with a franchise by the municipality


SECTION 2. Repealing Clause. All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 3. Separability Clause. This Ordinance partly amends, repels, and modifies Ordinance No. 2011-1082. Any inconsistency with previous/other ordinances, this Ordinance shall prevail. Any part which has been declared unconstitutional, the other parts shall remain in force.

SECTION 4. Effectivity. This ordinance shall take effect immediately after its approval.


