ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY LALAKAY, LOS BAÑOS, LAGUNA AMOUNTING TO ONE MILLION ONE HUNDRED THOUSAND PESOS ONLY (P 1,100,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay Lalakay, Los Baños, Laguna in the amount of One Million One Hundred Thousand Pesos Only (P 1,100,000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of One Million One Hundred Thousand Pesos (P 1,100,000.00) of Barangay Lalakay, Los Baños, Laguna shall cover the expenses for **SOCIAL DEVELOPMENT** : Procurement of Medicines and Vitamins - P 100,000.00; Procurement of Medical Supplies - P 100,000.00; Procurement of Disinfectant - P 100,000.00; Procurement of Relief Goods - P 500,000.00; **ENVIRONMENTAL MANAGEMENT** : Construction and rehabilitation of MRF - P 300,000.00


SECTION 3. SOURCE OF FUNDS – The amount of One Million One Hundred Thousand Pesos Only (P 1,100,000.00) of Barangay Lalakay, Los Baños, Laguna shall be sourced from the 20% Barangay Development Fund (BDF) prior year 2020;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
