ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY MALINTA, LOS BAÑOS, LAGUNA AMOUNTING TO NINE HUNDRED FORTY THOUSAND PESOS ONLY (P 940,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay Malinta, Los Baños, Laguna in the amount of Nine Hundred Forty Thousand Pesos Only (P 940,000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of Nine Hundred Forty Thousand Pesos (P 940,000.00) of Barangay Malinta, Los Baños, Laguna shall cover the expenses for the Procurement of Relief Goods - P 840,000.00 ; Procurement of Disinfectant - P 100,000.00;
- SECTION 3. SOURCE OF FUNDS** – The amount of Nine Hundred Forty Thousand Pesos (P 940,000.00) of Barangay Malinta, Los Baños, Laguna shall be sourced from the Continuing Balance (20% Barangay Development Fund (BDF) 2016-2020) ;


