ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY TUNTUNGIN-PUTHO, LOS BAÑOS, LAGUNA AMOUNTING TO THREE MILLION FOUR HUNDRED FIFTY THOUSAND PESOS ONLY (P 3,450,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay Tuntungin-Putho, Los Baños, Laguna in the amount of Three Million Four Hundred Fifty Thousand Pesos Only (P 3,450,000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of Three Million Four Hundred Fifty Thousand Pesos Only (P 3,450,000.00) of Barangay Tuntungin-Putho, Los Baños, Laguna shall cover the expenses for the Provision of Food and non-food item for marginalized sector affected by Covid-19 Pandemic - P 1,000,000.00; Rehabilitation of Multi-purpose Hall - P 750,000.00; Purchase and installation of Solar Panel for street light




SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


