ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY MAAHAS, LOS BAÑOS, LAGUNA IN THE AMOUNT OF SIX HUNDRED FIFTY THOUSAND PESOS ONLY (PHP 650,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Maahas, Los Baños, Laguna in the amount of Six Hundred Fifty Thousand Pesos Only (PhP 650,000.00) for Fiscal Year 2021;

SECTION 2. COVERAGE – The amount of Six Hundred Fifty Thousand Pesos Only (PhP 650,000.00) shall cover the expenses for **MOOE**: Electricity Expense – P 50,000.00; Water Expense – P 50,000.00; Office Supplies Expense – P 50,000.00; Other Supplies & Materials Expense – P 100,000.00; **CO**: Office Equipment Expense – P 25,000.00; ITCT Equipment Expense – P 25,000.00; **20% BDF**: Procurement of Food &


SECTION 3. SOURCE OF FUNDS – The amount of Six Hundred Fifty Thousand Pesos Only (PhP 650,000.00) of Barangay Maahas, Los Baños, Laguna shall be sourced from the Government Equity Surplus – P 300,000.00; Continuing 5% BDRRM (70%) – P 150,000.00 & Continuing 20% BDF – P 200,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2021 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
