**ORDINANCE NO. 2021-2139**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY SAN ANTONIO, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE MILLION TWO HUNDRED THOUSAND PESOS ONLY (PHP 1,200,000.00) FOR FISCAL YEAR 2021.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay San Antonio, Los Baños, Laguna in the amount of One Million Two Hundred Thousand Pesos Only (PhP 1,200,000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE – The amount of One Million Two Hundred Thousand Pesos Only (PhP 1,200,000.00) shall cover the expenses for **20% Barangay Development Fund**: Procurement of relief goods in relation to COVID-19 Pandemic – P 1,200,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of One Million Two Hundred Thousand Pesos Only (PhP 1,200,000.00) of Barangay San Antonio, Los Baños, Laguna shall be sourced from the Beginning Balance (20% BDF prior years 2014-2019) – P 1,200,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2021 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


