ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY TADLAC, LOS BAÑOS, LAGUNA IN THE AMOUNT OF SIX HUNDRED FIFTY THOUSAND PESOS (PHP 650,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Tadalac, Los Baños, Laguna in the amount of Six Hundred Fifty Thousand Pesos Only (PhP 650,000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE – The amount of Six Hundred Fifty Thousand Pesos Only (PhP 650,000.00) shall cover the expenses for 20% BDF: Food assistance and other relief goods for affected households – P 250,000.00; Procurement of Medicines and Vitamins – P 50,000.00; Procurement of Medical Equipment – P 90,000.00; Procurement of Medical Supplies – P 90,000.00; Procurement of disinfectants, sprayers, disinfection tents &

other disinfecting supplies and misting equipment's – P 40,000.00; Procurement of Personal Protective Equipment – P 20,000.00; Utilities of Barangay COVID-19 Facilities Electricity and Water Expenses – P 10,000.00; MOOE: Gasoline Expenses – P 60,000.00; Electricity Expenses – P 40,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Six Hundred Fifty Thousand Pesos Only (PhP 650,000.00) of Barangay Tadalac, Los Baños, Laguna shall be sourced from the Continuing Balance 20% BDF 2019-2020 – P 550,000.00 & Equity Surplus for MOOE – P 100,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2021 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
