


ORDINANCE REPEALING SECTION 2 PARAGRAPH (R) OF ORDINANCE NO. 2020-2001, "AN ORDINANCE ADOPTING THE INTER-AGENCY TASK FORCE RESOLUTION NO. 2020-003 DATED MARCH 29, 2020 "RESOLUTION PRESCRIBING COVID-19 GUIDELINES, POLICIES AND REGULATIONS AND PROVIDING PENALTIES FOR VIOLATION AND/OR NON-COMPLIANCE THEREWITH".

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. This Ordinance hereby repeals Section 2 Paragraph (R) of Ordinance No. 2021-2001:

SECTION 2. COVID-19 GUIDELINES. Pursuant to the various national issuances, including but not limited to those above cited, the following guidelines hereunder shall be strictly observed:

- R. The grocery stores, supermarkets and public markets odd-even dates scheme shall be strictly observed and implemented by the Philippine National Police, Barangay officials, volunteers guarding the public markets and market guards. The odd-even number shall be based on the dates of the month. Grocery stores, supermarkets and public markets Odd-Even Dates Scheme are as shown below:




