ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY BAMBANG, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS ONLY (P 100,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay Bambang, Los Baños, Laguna in the amount of One Hundred Thousand Pesos Only (P 100,000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of One Hundred Thousand Pesos Only (P 100,000.00) shall cover the expenses for **MOOE**: Additional Appropriation for Gasoline – P 35,000.00; Other supplies and material expenses – P 15,000.00; **CAPITAL OUTLAY**: Computer software – P 50,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Thousand Pesos Only (P 100,000.00) of Barangay Bambang, Los Baños, Laguna shall be sourced from the Beginning Balance (General Fund) – P 100,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2021 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.




