**ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 2021-2128 ENTITLED “AN ORDINANCE AMENDING ARTICLE 2 SECTION 4.13 OF ORDINANCE NO. 2011 - 1082 PERTAINING TO THE DEFINITION OF TRICYCLE.**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

**SECTION 1.** This ordinance amends Section 1 of Ordinance No. 2021-2128.

“Public Utility Tricycle – shall refer to a motorcycle/side car unit granted with franchise by the Municipal Government of Los Baños to operate and transport passengers within the municipality, it shall likewise include a three-wheeler passenger vehicle, with model classification of non-conventional three-wheeled motorized vehicle granted with a franchise by the municipality.”

*“Tricycle – means a motor vehicle composed of a motorcycle fitted to a single-wheeled side car to render transport services or to convey passenger/goods for public and private use. It shall likewise include a three-wheeler passenger vehicle, with model classification of non-conventional three-wheeled motorized vehicle.”*


**SECTION 2. Repealing Clause.** All ordinances, rules and regulations or parts not consistent with any provision of this Ordinance are hereby repealed, amended or modified accordingly.

**SECTION 3. Separability Clause.** This Ordinance partly amends, repeals, and modifies Ordinance No. 2021-2128. Any inconsistency with previous/other ordinances, this Ordinance shall prevail. Any part which has been declared unconstitutional, the other parts shall remain in force.


**SECTION 4. Effectivity.** This ordinance shall take effect immediately after its approval.
