ORDINANCE NO. 2021- 2161

AN ORDINANCE SUPPORTING THE POSITION OF MUNICIPAL AGRICULTURE AND FISHERY COUNCIL CHAIRPERSON TO PERFORM ITS DUTIES AND RESPONSIBILITIES BY AUTHORIZING A MONTHLY HONORARIUM OF ONE THOUSAND PESOS (PHP 1,000.00).

WHEREAS, pursuant to Section 19 of Executive Order 116 of 1987, the National Agricultural and Fishery Council shall act as an advisory body to ensure the success of the Department of Agriculture's programs and activities and serve as the forum for consultative and continuing discussions within the agricultural sectors; from the national level, it shall be replicated down to the regional, provincial, and municipal levels;

WHEREAS, Memorandum Circular No. 2000-62 dated May 23, 2000 of the Department of Agriculture on the LGU participation of the AFC's in the Local Development Council (LDC) ordering the creation of the Regional (RAFC), Provincial (PAFC), City (CAFC), Municipal (MAFC) and Barangay (BAFC) Agricultural and Fishery Councils;

WHEREAS, the AFC of every barangay has elected among them a Chairperson for the MAFC representatives to the municipal and national governing bodies;

WHEREAS, this ordinance shall help the MAFC Chairperson in coordinating with the local and national AFCs in the effective implementation of R.A. 8435 of 1987 (Agricultural and Fishery Modernization Act) together with the Office of the Municipal Agriculturist in formulating and

implementing programs and projects geared towards the alleviation of the people's economic condition by improving agriculture and fishery production;

WHEREAS, the granting of such honorarium will aid in providing service to the Agriculture and Fishery sector of the Municipality of Los Baños;

WHEREAS, the funds shall be utilized for the participation in meetings, dissemination of information, and other matters in line with the performance of its functions as MAFC Chairperson;

WHEREAS, Resolution No. 2015-10 as per Adjudication and Settlement Board Decision No. 2004-008 of the Commission on Audit recognizes honorarium, as not a grant to farmers, fisher folks and the community;

NOW THEREFORE, on motion of Councilor Cris Dayril B. Bagnes duly seconded by Councilor Janos S. Lapiz and approved by all the Councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE. An Ordinance Supporting the position of Municipal Agriculture and Fishery Council chairperson to perform its duties and responsibilities by authorizing a monthly travel/incentive allowance of one thousand pesos (Php 1,000.00).

SECTION 2. ELECTED MUNICIPAL AGRICULTURE AND FISHERY COUNCIL CHAIRPERSON. The elected Municipal Agriculture and Fishery Council Chairperson shall hold office for a term of one (1) year.

SECTION 3. COMPENSATION and APPROPRIATION. A Municipal Agriculture and Fisher Council Chairperson shall be entitled to a monthly honorarium of One Thousand Pesos (Php 1,000) to be funded from Municipal Agriculturist Office - General Fund.


SECTION 4. REPEALING CLAUSE. All previous ordinance contrary to, or inconsistent with this Ordinance shall be deemed repealed or modified accordingly.


SECTION 5. SEPARABILITY CLAUSE. If any part of this Ordinance is declared unconstitutional or unlawful, such declaration shall not affect the enforceability of the remaining provisions of this Ordinance.

SECTION 6. EFFECTIVITY. This Ordinance shall take force and effect upon its approval.
