ORDINANCE NO. 2021 - 2169

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY LALAKAY, LOS BAÑOS, LAGUNA AMOUNTING TO ONE MILLION FIFTY THOUSAND PESOS ONLY (P 1,050,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 2 of Barangay Lalakay, Los Baños, Laguna in the amount of One Million Fifty Thousand Pesos Only (P 1,050,000.00) For Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of One Million Fifty Thousand Pesos (P 1,050,000.00) of Barangay Lalakay, Los Baños, Laguna shall cover the expenses for MOOE : Electricity Expense - P 80,000.00; Fuel, Oil and Lubricant Expense - P80,000.00; Water Expense - P 10,000.00; Procurement of Industrial fan and Printer - P 30,000.00; Repair and Maintenance Transportation Equipment - P 26,000.00; CAPITAL OUTLAY: Fabrication of Cabinet - P 20,000.00; ENVIRONMENTAL

MANAGEMENT : Provision of Allowance for 2 Garbage Collector and 1 Driver - P 54,000.00; Purchase of Dump Truck - P 750,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Seven Hundred Fifty Thousand (P 750,000.00) shall be sourced from the Continuing Balance (20% BDF) and Three Hundred Thousand (P 300,000.00) Pesos shall be sourced from Beginning Balance (General Fund);

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


