ORDINANCE NO. 2021 - 2174

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY TADLAC, LOS BAÑOS, LAGUNA IN THE AMOUNT OF TWO HUNDRED EIGHTY TWO THOUSAND PESOS ONLY (P 282,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay Tadalac, Los Baños, Laguna in the amount of Two Hundred Eighty Two Thousand Pesos Only (P 282,000.00) For Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of Two Hundred Eighty Two Thousand Pesos Only (P 282,000.00) Barangay Tadalac, Los Baños, Laguna shall cover the expenses for MOOE : Additional Appropriation for Electricity Expenses - P 50,000.00; Gasoline Expenses - 170,000.00; Procurement of Office Supplies - P 30,000.00; Accountable Forms - P10,000.00; Procurement of Tarpaulin for Barangay Announcement - P 22,000.00;




SECTION 3. SOURCE OF FUNDS – The amount of Two Hundred Eighty Two Thousand Pesos (P 282,000.00) of Barangay Tadalac, Los Baños, Laguna shall be sourced from Beginning Balance (General Fund);

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
