ORDINANCE NO. 2021 - 2180

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY ANOS, LOS BAÑOS, LAGUNA IN THE AMOUNT OF FOUR HUNDRED THIRTY THOUSAND PESOS ONLY (P 430,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Anos, Los Baños, Laguna in the amount of Four Hundred Thirty Thousand Pesos Only (P 430,000.00) for Fiscal Year 2021;

SECTION 2. COVERAGE – The amount of Four Hundred Thirty Thousand Pesos Only (P 430,000.00) Barangay Anos, Los Baños, Laguna shall cover the expenses for MOOE : Procurement of Office Supplies - P 80,000.00; Additional Appropriation for: Gasoline Expenses - 80,000.00; Electricity Expenses - 100,000.00; Water Expenses - P 20,000.00; Telephone / Mobile Expenses - P 40,000.00; Repair / Maintenance Transportation Equipment -P 80,000.00; Representation Expenses - P 30,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of Four Hundred Thirty Thousand Pesos (P 430,000.00) shall be sourced from Beginning Balance (General Fund);

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


