
ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY MAYONDON, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE HUNDRED SIXTY THOUSAND PESOS ONLY (P 160,000.00) FOR FISCAL YEAR 2021.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 2 of Barangay Mayondon, Los Baños, Laguna in the amount of One Hundred Sixty Thousand Pesos Only (P 160,000.00) for Fiscal Year 2021;
- SECTION 2. COVERAGE** – The amount of One Hundred Sixty Thousand Pesos (P 160,000.00) of Barangay Mayondon, Los Baños, Laguna shall cover the expenses for MOOE : Payment for Electric Consumption - P 80,000.00 and Payment for Gasoline Consumption - P 80,000.00;




SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Thousand Pesos (P 100,000.00) shall be sourced from Beginning Balance (General Fund 2020) and Sixty Thousand Pesos (P 60,000.00) shall be sourced from Realignment / Reversion / Reprogramming of Capital Outlay in the Procurement of One (1) Unit Motorcycle Service of Barangay Mayondon, Los Baños, Laguna;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
