**ORDINANCE NO. 2021-2186**

**AN ORDINANCE RECONSTITUTING THE MUNICIPAL TRICYCLE AND PEDICAB FRANCHISING AND REGULATORY BOARD (MTPFRB) OF LOS BAÑOS, LAGUNA.**

**WHEREAS**, Section 447 (3-vi) of RA 7160 also known as the Local Government Code of 1997 states that “the Sangguniang Bayan, subject to the guidelines prescribed by the Department of Transportation and Communication, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality”;

**WHEREAS**, the Sangguniang Bayan of Los Baños enacted Municipal Ordinance 2011-1082 dated October 17, 2011 entitled “New Municipal Ordinance on the Franchise and Operation of Motorized Tricycles in Los Baños, Laguna to be known as the “New Ordinance for Tricycles in the Municipality of Los Baños”/ *Bagong Kautusang Pambayan na Nagsasaad ng Pagpapaprangkisa at Pamamahala ng Operasyon sa Lahat ng Traysikel na may Motor sa Bayan ng Los Baños, Laguna na Tatawaging “Bagong Ordinansa para sa mga Traysikel sa Bayan ng Los Baños”;*

**WHEREAS**, Article 3 of said Ordinance provides for the organization of Municipal Tricycle Franchising and Regulatory Board (MTFRB), a policy-making body with regards to tricycle operation in the municipality. Section 5.1 states that the Board shall be composed of the Municipal Mayor as Honorary Chairman and the Municipal Vice Mayor as the Chairman;

**WHEREAS**, on March 13, 2017, Ordinance No. 2017-1618 was enacted which provides for the new composition of the Municipal Tricycle and Pedicab Franchising and Regulatory Board (MTPFRB). It states that the Municipal Mayor is the Chairman while the Municipal Vice Mayor is the Vice Chairman of the Board;

**WHEREAS**, there is a need to reconstitute the MTPFRB;

**NOW THEREFORE**, on motion of Councilor Marlo PJ A. Alipon duly seconded by Councilor Geronimo A. Cceron and approved by the councilors present;

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, IN SESSION ASSEMBLED, THAT:**

**SECTION 1. COMPOSITION.** The Municipal Tricycle Pedicab Franchising and Regulatory Board is hereby reconstituted, as follows:

**Honorary Chairperson :** Municipal Mayor

**Chairperson :** Municipal Vice Mayor

**Vice Chairperson :** SB Chairman of the Committee on Transportation and Communication

**Members :**

SB Chairman of the Committee on Appropriation, Ways and Means

SB Chairman of the Committee on Peace and Order

Municipal Planning and Development Coordinator (MPDC)

Municipal Engineer




